*For 26 years, we have continued to be creative in meeting the needs of our clients and their families. This past year was one of great expansion and we are very pleased with the success of our new programs to fill the needs of an expanding population.*

- In 2013, CAREERS secured 120 new job placements for individuals with disabilities throughout Westchester and Putnam Counties – an 11% increase over the prior year. Equally important, we helped the majority of our clients retain their jobs – even as the general populous continued to experience layoffs.
  - CAREERS provided supported employment services to 350+ individuals in need.
  - CAREERS coordinated Disability Mentoring Day in both Putnam and Westchester Counties on October 17, 2013. A total of 33 disabled individuals were mentored by County personnel in varied departments and positions throughout both counties to gain workplace experience.
  - Our Ambition In Motion (AIM) day habilitation program without walls was launched in September 2013, providing workplace readiness skills and community activities to participants who do not yet have the skills to participate in a traditional supported work program.
