One of the joys of preparing an annual report is that it gives us the opportunity to look back and be thankful for all that has been accomplished. The past fiscal year was filled with wonderful opportunities and many challenges. The following are some of our highlights:

- *In 2010, CAREERS secured 78 new job placements for individuals with disabilities throughout Westchester and Putnam Counties. Equally important, we helped the majority of our clients retain their jobs – even as unemployment rose in the general populous.*
- *CAREERS provided supported employment services to over 450 individuals in need.*
- *CAREERS continued its successful “School-to-Work”, “Community Transition”, and “Corporate Outreach” programs to serve high school students with disabilities and individuals in community psychiatric programs to help them transition into the workforce.*
- *We added two new classroom-style curriculum-based programs called “Workforce Readiness, Placement & Training Program” and “Financial Education Training Program”.*
